There is a \$50 application fee for space rental and a \$45 fee for garbage disposal. Water, sewer or electrical services will not be provided. Let us know what size space you need. All food vendors must be self-contained. Vendor set up is available to start at 8am with food needing to be available for sale to the public at 1pm and remain open until 8pm. Break down and load out will be completed by 9pm. Please keep your vehicle parked in the vendor parking area. After breakdown park in vendor parking and feel free to enjoy the rest of the festival. All canopies, tents, and structures must be free-standing and secured in the event of strong winds or other weather conditions. All food vending equipment must be off the golf course property by 11pm Saturday, June 28, 2025.
